2. SERVICES INCLUDED

- Age-matched sessions delivered classroom by classroom.
- On-site visits for up to 6 classrooms.
- Props, books and activity setups included in every session.
- Teacher extension tips after each visit.

3. CLASSROOM OPTIONS

- Sensory Story Seekers (birth-18 months) — 30 minutes: lap-songs, fingerplays, high-contrast and touch-and-feel board books, soft sensory props.

- Tales in Motion (18 months–3 years) — 45 minutes: interactive read-aloud with repetition and movement, puppet play, shakers, sensory bin or process art, take-home activity idea.
- Storybook Creators (3–5 years) — 60 minutes: dramatic read-aloud with discussion and prediction, STEAM or literacy center, letter-sound/rhyming/sequencing game, cooperative retelling project.

4. PAYMENT TERMS

- Invoices are issued in advance of each service period and are due on receipt unless another date is stated in writing.
- Recurring monthly packages are billed on the same calendar day each month until cancelled in writing.
- Parties and private events require a 50% non-refundable deposit to reserve the date, with the balance due 7 days before the event.
- Payments may be made through the secure payment portal at thereadingengagement.org/pay.
- Returned or failed payments may incur a \$25 fee, and services may be paused until the balance is current.

5. SCHEDULING, CANCELLATION & RESCHEDULING

- Session dates and times are confirmed in writing before the first visit.
- Client cancellations with at least 48 hours notice may be rescheduled once at no charge, subject to availability.
- Cancellations with less than 24 hours notice, or a closed/inaccessible site on arrival, are billed in full.
- If The Reading Engagement must cancel, the session is rescheduled or credited at no cost to the Client.
- Either party may end a recurring agreement with 30 days written notice; fees already billed are not refunded.

6. CLIENT RESPONSIBILITIES

- Provide a safe, clean and adequately supervised space appropriate for the age group served.
- Maintain required adult-to-child ratios at all times; The Reading Engagement staff enrich programming and do not replace the Client's supervision or licensing responsibilities.
- Share relevant allergies, sensory needs, medical conditions and behavior plans before the first session.
- Ensure photo/video permissions are secured from families if the Client requests media capture.

7. HEALTH & SAFETY

- Children or staff with fever, contagious illness or symptoms within 24 hours of a session should not participate.
- All props, books and materials are cleaned between programs.
- The Reading Engagement follows the Client's site emergency procedures while on the premises.

8. LIABILITY WAIVER & RELEASE

- The Client acknowledges that story time, movement, sensory play and craft activities carry inherent risks, including minor injury, allergic reaction and soiled or damaged clothing.
- The Client releases and holds harmless The Reading Engagement, its owners, employees, contractors and volunteers from claims arising from participation, except for gross negligence or willful misconduct.
- The Client is responsible for informing participating families of the nature of the activities and of this release.
- Total liability of The Reading Engagement under this agreement is limited to the fees paid for the affected session.

9. MEDIA, MATERIALS & CONFIDENTIALITY

- Curriculum outlines, extension guides and printed materials are provided for the Client's internal use and may not be resold or redistributed.
- Neither party will share the other's confidential business or family information without written consent.
- Media capture and marketing use of images requires written permission from the Client and participating families.

10. GENERAL TERMS

- This agreement is the complete understanding between the parties and replaces prior discussions.
- Amendments must be in writing and signed by both parties.
- This agreement is governed by the laws of the state in which services are delivered.
- If any provision is found unenforceable, the remaining provisions stay in effect.
